OBJETIVOS DE LA ASIGNATURA

Theoretical and practical analysis of the description, classification and transcription of the English phonic system. The organisation of speech and its variants will be studied. Its segmental study will consist of the acoustic and perceptual description of English vowels and consonants. The suprasegmental analysis will deal with the different possibilities offered by sounds in connected speech, with references to stress and rhythm both in English and Spanish. Finally, the study of the description, functions and acoustic analysis of intonation will be carried out.

ACTIVIDADES EN QUE SE ORGANIZA

Theory sessions: presentation and explanation of topics. The emphasis will lie on the practical implications of the theoretical points, although the grapho-phonological dimension will not be a priority.

Practical sessions: they will turn around two main fields:

- Phonological transcription: dictation of text, followed by the exploitation of how the main theoretical issues recently covered in the programme are reflected in it.
- Work in the language laboratory: working with drills, discrimination exercises and explanation of theoretical issues in connection with the recorded material.
